HIGHWAYS ACT 1980  
THE A120 TRUNK ROAD (M11 JUNCTION 8b AND AIRPORT ACCESS)  
ORDER 20

The SECRETARY OF STATE FOR TRANSPORT is considering implementation of a project for a new junction on the M11 Motorway to improve road access into an expanded Stansted Airport.

She gives notice that to enable her to determine whether to implement the project she has published an Environmental Statement as required by Part VA of the Highways Act 1980, and proposes to make the following Order:

1. An Order under sections 10 and 41 of the Highways Act 1980 which will:
  - (1) provide that roads which she proposes to construct along the following routes at Birchanger in the County of Essex shall become trunk roads from the date when the Order comes into force:
    - (a) a route to connect the existing A120 roundabout at M11 Junction 8 with a roundabout that she proposes to construct;
    - (b) a route to connect the existing southbound slip road to the A120 roundabout at M11 Junction 8 with a new slip road that she proposes to construct;
    - (c) a route to connect the roundabout that she proposes to construct to the new Stansted airport infra-structure; and
    - (d) the route of a roundabout.

ANY PERSON MAY OBJECT to the making of the Order or comment on the Environmental Statement not later than 26 June 2008, or within 13 weeks from the date of first publication of this notice if that period expires later, by notice to the Secretary of State for Transport at the offices of the Highways Agency, Woodlands, Manton Lane, Manton Industrial Estate, Bedford MK41 7LW marked for the attention of Anna Smyth quoting reference HA 65/2/133. Any objection to the Order must give the grounds on which it is made. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of it may be communicated to other people who may be affected.

Before deciding whether to proceed with the project the Secretary of State will consider any comments made about the Environmental Statement and the Secretary of State for Transport and the Secretary of State for Communities and Local Government will consider jointly any objections to the draft order.
